#### Abstract:

#### **I.INTRODUCTION**

At present, in the research of sports tourism, the research on Yunnan ethnic minority sports tourism mainly focuses on the distribution of sports resources and the layout of products, sports tourism policy orientation, product development, and talent training. Among them, Liu Xiaoming(2014) [1] argues that the promotion of the market, enterprises and government can make sports and tourism fully dovetail in terms of market and resources. Lu Changbao(2015) [2] argues that China's sports tourism generally suffers from a single product structure, low service level, low tourist satisfaction and loyalty, and the outreach and connotation of the product experience have not been fully explored. Research on medical tourism has also focused on the concept of medical tourism, influencing factors, product development and market exploitation. Among them, Li Ping (2015) [3] and Liu Jianguo(2016) [4] both combed and analyzed the relevant literature on medical tourism research at home and abroad, and put forward an outlook on the research and practice direction of medical tourism in China. Beijing, Shanghai, Guangxi and Yunnan have also launched medical tourism development policies, giving policy and cultural atmosphere support to the integration of Yunnan ethnic minority sports tourism and medical tourism. Based on the analysis of the feasibility analysis of the integration of Yunnan ethnic minority sports tourism and medical tourism, the Study examines the dynamic mechanism of the docking of the two and lays the foundation for further research on the operational model of their integration and development.

In addition to the above-mentioned groups of patients who need the psychological comfort of seeking medical treatment at sacred sites, other ethnic groups engage in tourism activities more for the purpose of experiencing not only the ethnic pilgrimage specific to the destination, but also to experience other heterogeneous cultures (such as language, art, food, etc.) to create a psychological demand for a "new self". Therefore, in the cultural activities of various ethnic groups, the unique sports culture is also included, such as the "Dancing when invites the guest" (Figure 1) of the Yi people in Shijian, Yunnan Province, the toasting ceremony (Figure 2), the left-foot dance of the Chuxiong Yi people (Figure 3), the moon dancing performance of the Honghe Yi people (Figure 4), and the observation and participation of various sports competitions in the folk culture square. The process of experiencing heterogeneous cultures makes people feel good about them, and the continuous diversion of their attention releases them from psychological stress, which has a significant purifying and rehabilitative effect on patients, especially those whose purpose is to treat illness.
